# Organized Hamlet of Hitchcock Bay AGM Minutes July 20, 2024 @ The Shack

#### Meeting Called to Order at 9:42 am

#### A. Reports:

## 1. Financial Report

  - a.i. Total Revenue for 2023: \$375,748.10
  - a.ii. Total Expenses for 2023: \$214,374.90
  - a.iii. No issues arose from the report
- b. Carla Schrader made a motion to accept the report. Tony Daigneault seconded. Carried.

#### 2. RM Report

- a. Carla Schrader reported on activity by RM for Hitchcock Bay and area. This activity included:
  - a.i. New RM shop to be built in Birsay.
  - a.ii. Dust control on grids near farms has been completed.
  - a.iii. Contact Carla (404 Vivian Bay) or call Lindsay at the RM office if there are concerns.
  - a.iv. Thank yous were given for well-kept roads all winter and for Lindsay's quick response time when called or asked for something.

- b. Patti Forrest motioned to accept the report. Seconded by Paula Crawford. Carried.

#### 4. Park Planning and Shack Report

- a. Andrea Fleck reported on the activity of the committee over the past year. Highlights include:
  - a.i. New golf path was initiated from Ruby south to the Shack.
  - a.ii. 5 permanent exercise stations were put in place
  - a.iii. Motion cameras and motion sensor lights were installed due to previous acts of vandalism around the park and Shack.
  - a.iv. Disc golf equipment was installed and improvements were made around the court.
  - a.v. Youth program will run again this year. Thanks to Paula and her helpers for running this.

# 5. Lucky Lake Fire Corp Report

- a. Dave Deutscher reported. This Corp is for Lucky Lake, Hitchcock Bay, Coteau and area.
  - i. This corp oversees the spending of funds in the areas listed above.
  - ii. A rapid response truck has been purchased and will be housed in Birsay
  - iii. Discussion regarding response teams and the need for an alert system (siren, WhatsApp communication system, etc).
- b. Motion to accept the report was made by Willie McLorreston; seconded by Carla Schrader.

# 6. Swimming Club Report

- a. Carrie Knight reported that this is the 34th year for swim lessons at Hitchcock Bay.
  - a.i. Lessons start on Monday, July 22 and run for 2 weeks. Cost is \$25.00/participant per week. Lessons will run from 8:30 am 2:00 pm.
  - a.ii. There are 58 registered swimmers for next week. If you still want to register, contact Carrie at 306-858-7166 asap.
  - a.iii. Head instructor this year is Caitlyn Knight.

- a.iv. Thank you to Carrie's volunteer corps: Curtis Knight, Bob Long, Caitlyn Knight, Hayden Churchman, Ksenya Churchman, and Eva Churchman for help with docks, buoys, and beach tidy-up last weekend.
- b. Motion to accept the report was made by Larry Pederson; seconded by Jean Vaxvick.

# B. Old Business:

#### 1. Vivian Bay Road- What is being done?

- a. Dave talked to Jeff about getting more heavy gravel to pack into the ground followed by finer gravel coating.
- b. Heavy rains this spring did a lot of damage to existing repair work.
- c. Suggestion was made to talk to Dale Wright (resident) who might be able to help.
- d. Ditch safety concerns still need to be addressed.

## 2. Boat Launch Status- North side still closed

- a. We have received the permit to at slurry (fill-crete) to repair and will do so once the water level is down.
- b. Rerouting water run-off on north side being investigated.

## 3. Ice Shacks

a. There is a plan to clean up the area and possibly plant trees/shrubs to improve aesthetics.

b. All shacks should be required to include a name and contact number.

c. Can the conservation officer be part of a plan to regulate usage of this area?

d. Can we have a shack storage sign-up on the HB website?

#### C. New Business:

#### 1. 2024 Property Tax Increase

- a. There will be a base tax increase of \$15.00 to \$640.00 this year.
- b. No increase in school tax.

#### 2. Sale of Storage Lots to Public

- a. The cost of the lots north of the boat launch area is currently \$36,000.00 for residents with the stipulation the building must begin within 4 years of purchase.
- b. Sales have stagnated. Should we consider opening this to the public?
  - b.i. More advertising to residents should occur first, the open a limited public sale to residents in Hitchcock Hideaway, Lucky Lake, Birsay, and Coteau areas.
  - b.ii. Suggested that public purchase price could increase by \$5,000.00.

#### 3. Permits/Boat Launch Fees

- a. Currently the fees are set as cabin owners (free), public \$10.00 daily, \$50.00 annual. This is much cheaper than other launches in the area.
- b. Should there be a fee for cabin owners? \$25.00? \$50.00? Annually.

- c. Motion by Carla Schrader: There will be a \$50.00 annual fee for residents (per lot) for use of the boat launch starting in 2025 and collected by the board. Seconded by Paul Tucker. Carried.
- d. Motion by Carrie Knight: Boat launch fees will increase to \$20.00 daily and \$100.00 annually for non-residents. Seconded by Chris Phillips. Carried.

#### 4. Camper Parking

- a. Visitors that park their campers in resident lots have a 30 day max to their stay.
- b. Campers are not supposed to be parked in the green spaces.
- c. Dave will look into the bylaws regarding this and see if the RM can help with enforcement if needed.

## 5. Election of 1 new board member (3 year term)

-Wayne Vaxvick has agreed to stay on for another term. Any nominations from the floor? Nominations cease.
